

**NCCC  
YOUTH COUNCIL  
MEETING MINUTES**

**February 17, 2011**

**1. Call To Order**

The meeting was called to order by Youth Council Chair Eric Pomeroy at 1:35 pm at the Sutter County Superintendent of Schools Sierra Building Facility in Yuba City, CA.

**2. Roll Call**

**3. Approval of Minutes**

**4. Youth Council Membership Application**

Due to lack of a quorum of the Youth Council, action items 3 and 4 were carried over to the next scheduled meeting.

**5. NCCC Youth Council Resource Website**

Lettie Seaver mentioned that at the last meeting, the Youth Council had agreed to the development of a youth services resource guide website. Lettie handed out a printout of NCCC's new Virtual One Stop (VOS) home page – [www.northcentralworks.com](http://www.northcentralworks.com) – and pointed out the links for youth services. These links would direct youth to additional links to NCCC One Stops and to research career, education and training information. Links to the One Stops can be found on NCCC's website as well.

Karen Peters was of the opinion that since the Youth Council is part of NCCC's Workforce Investment Board, youth resource information should be a page off NCCC's website rather than be a separate website. Lettie pointed out that at the present time NCCC's website is not able to sustain comprehensive youth services information. Once the website can operate at its full capacity, relevant youth resource information can be incorporated onto the site. It was noted that a central point of access to all youth resources within the consortium would be easier for youth to find the information they need rather than clicking through several links

Eric Pomeroy presented a mock-up of what a potential web page could look like. The web page, modeled after the existing NCCC website, included all the information about the Youth Council and links that would connect youth to the One Stops and youth resources throughout the consortium. Once fully developed the Youth Council webpage could be linked to from NCCC's main and VOS websites. Jami Larson (*corrected*) and Eric Pomeroy commented that with this webpage all youth resources within the consortium would be in one location and it would give the youth a webpage specifically targeted for them where they can surf for information they need in one area instead of having to go to five individual county websites.

Members were asked to send their resource links and information to Eric at [ericp@sutter.k12.ca.us](mailto:ericp@sutter.k12.ca.us) and he would begin posting them on the webpage.

## **6. Other News**

Members discussed the funding cuts being proposed for the WIA, YouthBuild and Carl Perkins programs.

David Darling commented that Northern California Construction Training provides good training programs in heavy carpentry.
